### 1. Introduction

---

These Terms and Conditions ("Terms") govern your access to and use of the 2BME Expert Connect platform ("Platform"), operated by 2BME, Inc. ("2BME", "we", "us", or "our"). The Platform is accessible via [www.2bme.de](http://www.2bme.de) and connects two types of users: individuals seeking guidance in skincare, aesthetics and wellness ("Clients"), and experienced professionals offering consultation services ("Experts").

2BME Expert Connect is a decision-support platform where individuals can connect with experienced professionals to gain contextual understanding, risk awareness, and informed guidance in aesthetic, beauty and wellness treatments.

By registering, accessing, or using the Platform in any capacity, you agree to be bound by these Terms. If you do not agree, you must not use the Platform.

2BME is a US-registered company incorporated in the State of California. The 2BME trademark is registered in Germany. These Terms are governed by the laws of the State of California, United States, without regard to conflict of law principles.

### 2. Definitions

---

- "Platform" means the 2BME Expert Connect service available at [www.2bme.de](http://www.2bme.de), including all associated pages, features, and tools.
- "Expert" means a registered professional who offers paid consultation sessions to Clients through the Platform.
- "Client" means any individual who browses Expert profiles and books paid consultation sessions through the Platform.
- "Session" means a paid one-on-one consultation between a Client and an Expert conducted via video, phone, or chat.
- "Registration Fee" means the annual fee paid by Experts to list on the Platform.
- "Platform Fee" means the percentage of each Session fee retained by 2BME as a service charge.

### 3. Role of 2BME — We Are a Marketplace

---

2BME operates as a marketplace and technology platform only. We connect Clients with Experts. We do not ourselves provide skincare advice, medical advice, aesthetic treatments, or professional services of any kind.

2BME is not responsible for the content, quality, accuracy, or outcomes of any consultation or advice exchanged between users on the Platform. All consultations are conducted directly between the Expert and the Client.

2BME does not employ, endorse, or certify any Expert listed on the Platform. Listing on the Platform does not constitute a professional endorsement by 2BME.

## 4. Terms for Experts

---

### 4.1 Registration

To list on the Platform as an Expert, you must complete the registration form and pay the applicable annual Registration Fee. The following plans are available:

- Listing (€25/year): Map listing and profile only. No consultation booking functionality.
- Expert (€49/year): Full listing plus the ability to receive and accept paid consultation bookings from Clients. A 15% Platform Fee applies to each Session.
- Premium (€299/year): All Expert features plus featured placement on the map, 1 weekly promotional post in the 2BME Facebook group (140,000+ members), and a reduced 10% Platform Fee per Session.

Registration Fees are non-refundable once payment has been received and your listing has been activated.

### 4.2 Platform Fee

For Expert and Premium plan holders, 2BME retains a Platform Fee of 15% (Expert) or 10% (Premium) of each Session fee paid by a Client. The remaining amount is transferred to the Expert. The method and timing of payment to Experts will be confirmed at the time of booking.

### 4.3 Expert Responsibilities

By registering as an Expert, you confirm and agree that:

- You are qualified, trained, and legally permitted to provide the type of advice or services you offer in your registered country.
- All information provided in your profile is accurate, truthful, and up to date.
- You will respond to booking requests within your stated response time.
- You will conduct Sessions professionally and in accordance with applicable laws and professional standards.
- You will not provide advice that is outside your area of qualification or expertise.
- You will not solicit Clients to bypass the Platform for future sessions once introduced through 2BME.
- You will update your availability status (green/orange/red) promptly and accurately.

#### **4.4 Medical and Professional Disclaimers**

Experts must clearly communicate to Clients that consultations provided through the Platform are informational and educational in nature and do not constitute medical advice, diagnosis, or treatment. Experts who are not licensed medical professionals must make this clear before and during any Session.

## **5. Terms for Clients**

---

### **5.1 Booking a Session**

Clients may browse Expert profiles and book a paid Session through the Platform. By booking a Session, you agree to pay the Expert's stated fee plus any applicable service charges. Payment must be made in advance through the Platform's designated payment method.

### **5.2 Guidance and Decision Support Only**

You understand and acknowledge that:

- The 2BME Expert Connect platform provides guidance and decision support only and does not replace medical advice or treatment.
- Consultations provided by Experts through the Platform are informational and educational in nature only.
- No Expert on this Platform is acting as your doctor, dermatologist, or licensed medical professional unless they explicitly state their medical qualifications.
- Any advice received during a Session should not replace professional medical diagnosis or treatment.
- If you have a medical condition, skin disorder, or health concern, you should consult a licensed medical professional before undertaking any skincare or aesthetic treatment.

### **5.3 Your Responsibility**

You accept full personal responsibility for any treatments or decisions you make following a consultation. 2BME and the Expert are not liable for any adverse outcomes resulting from actions taken based on consultation advice.

### **5.4 Cancellations and Refunds**

If an Expert cancels a confirmed Session, you will receive a full refund. If you cancel a Session, the following applies:

- Cancellation more than 24 hours before the Session: full refund.
- Cancellation less than 24 hours before the Session: no refund, unless the Expert agrees otherwise.
- If an Expert fails to appear for a confirmed Session without cancellation: full refund.

## **6. Prohibited Conduct**

---

All users of the Platform agree not to:

- Provide false, misleading, or inaccurate information during registration or in their profile.
- Impersonate any person or misrepresent professional qualifications or credentials.
- Solicit other users to conduct transactions outside the Platform in order to avoid Platform Fees.
- Use the Platform to promote illegal activities, unsafe practices, or content that violates applicable law.
- Harass, abuse, or threaten other users of the Platform.
- Share session content, personal data of other users, or confidential information without consent.
- Use the Platform in any way that could damage, disable, or impair its proper functioning.

2BME reserves the right to suspend or permanently remove any user who violates these Terms, without refund of Registration Fees.

The 2BME name and trademark are registered intellectual property of 2BME, Inc. in the United States and Germany. All content on the Platform, including design, text, graphics, and software, is the property of 2BME, Inc. and may not be copied, reproduced, or distributed without written permission.

To the maximum extent permitted by applicable law, 2BME, Inc. shall not be liable for:

- Any indirect, incidental, special, consequential, or punitive damages arising from your use of the Platform.
- Any adverse health outcomes resulting from consultations, skincare advice, or treatments undertaken following use of the Platform.

- The conduct, qualifications, or actions of any Expert listed on the Platform.
- Any loss of data, revenue, or business opportunity arising from use of or inability to use the Platform.

In no event shall 2BME's total liability to any user exceed the total Registration Fee paid by that user in the 12 months preceding the claim.

## 10. Dispute Resolution

---

In the event of a dispute between a Client and an Expert arising from a Session, both parties agree to first attempt to resolve the matter directly.
